VHIR offers a vacant position for a **Project Manager** within the Liver Diseases Research Group, with a specific focus on clinical trials for non-alcoholic steatohepatitis (NASH), within the framework of the EU-PEARL (EU Patient Centric Clinical Trials Platforms) IMI2 European Project.

JOB DESCRIPTION

Education and qualifications:

- University Degree within Life Sciences.
- A PhD will be valued.

Experience and knowledge:

- At least 2 years of experience working in research institutions in European project management related activities, in scientific and clinical environments.
- Previous experience in the coordination of European projects will be highly considered.
- Knowledge on clinical trial monitoring will be highly considered.
- Excellent written and oral communication in Spanish and English. Catalan is also valued.
- Good command of MS Office and other computer tools.
- Personal skills: well-organized, proactive, results oriented professional with close attention to detail and with the ability to work under tight deadlines and multicultural teams. Team player with excellent interpersonal skills.

Main responsibilities and duties:

The selected candidate will work as Project Manager at the Liver Diseases Group, supporting the activities of the Group in relation to the strategic project EU-PEARL (Patient Centric Clinical Trials Platforms), within a Consortium of 36 international partners. The project is coordinated by VHIR, that also leads a work package (WP) focused on platform trials for NASH. The project is funded by the Innovative Medicines Initiative 2 Joint Undertaking of the EU, with a total budget of EUR 26M.

EU-PEARL is a unique public-private strategic partnership focus on creating a framework to set-up adaptive clinical trials platforms of the future. The Project aims to transform clinical trials into a cross-company collaborative, multi-compound platform focused on patients. It will define a novel enabling infrastructure through an integrated system where pharmaceutical companies and healthcare providers can work together and integrated research platforms will become an obtainable alternative.

Within the contribution of the Liver Diseases Research Group to the EU-PEARL Project, day-to-day activities of the selected candidate might include:

- To contribute to the planning and to monitor the Work Plan (scope, resources, time management, etc.) of the tasks assigned to the Group, in strong collaboration with the Principal Investigator and the medical team.
- To liaise with and support the Principal Investigator regarding communication with Project partners and the WP teams, to ensure the proper implementation of Project activities.
- To support the internal and external communication of the project, participating in and supporting the organization of WP- and project-meetings as requested.
- To liaise with the EU-PEARL Project manager at VHIR for the monitoring of the project, in relation to the Group and WP contribution.
- Support in other tasks related to the preparation and drafting of project proposals and reports, financial management, meetings and events preparation, etc.

The candidate will also be part of the team within the Liver Diseases Research Group in charge of NASH and NASH clinical trials. The candidate will support the team with the management of clinical trial activities; linking the implementation of the activities defined in EU-PEARL work plan to the activities of the clinical trials of the group (contract implementation; data managing; communication with CROs, sponsors and other stakeholders; and budget and organizational overseeing of clinical trials).
