The Role

The EIT Health Spain Innovation Platform Trainee will mainly support the Innovation Team in their tasks related to building and managing a growing portfolio of projects. The position covers a range of IT, accounting, administrative, quality management and procurement functions. Those tasks will be complemented with increasing interaction with other members in the network and involvement in the definition of planning and processes.

We are seeking a self-paced, curious and efficient Innovation Platform Trainee to contribute to the seamless delivery of services offered by the CLC Spain. This work is for you if you are looking to develop your career in the IT/Healthcare industry, brave to learning new things every single day, passionate about continuous improvement, creating impact and building long-lasting relationships. The post holder will also contribute to the development of IT platforms and tools for the use of the whole team at EIT Health Spain and external stakeholders, in coordination with the EIT infrastructure and resources. This means that you must have hands-on experience in developing similar solutions and your work will have to be useful for a range of diverse users, both internal and externally, meeting quality and legal requirements.

This is a challenging and exciting multidisciplinary role that will require high levels of resilience, flexibility and drive for results. The post holder reports directly to the EIT Health Spain Innovation Manager and works in close collaboration with the rest of Spanish Pillar Managers, the EIT Health Communication Team, Managing Director, the KIC Partners and the EIT Health Spain ecosystem representatives, in coordination with HQ and other CLC/InnoStars related positions.

Main Responsibilities

As an Innovation Platform Trainee, your work will include:

- Supporting the three EIT Health departments or “pillars” (Innovation, Business Creation and Campus) through the conception, design, planning, coordination, implementation, update and follow-up of adequate IT tools and platforms using an iterative approach.
 - Development and update the different databases and managing platforms (customers, procurement, documents, events, proposals and projects)
 - Development of the CLC Spain Innovation one-stop-shop (repository)
 - Development of marketplace tools to facilitate partner/service search
 - Development of training material and documentation for the services developed
- Administrative tasks:
 - Management of documents and shared folders
 - Elaboration of minutes of meetings, summaries and compilation of Frequent Asked Questions (FAQs)
 - Text/Video editing and copywriting
 - Creation of presentations and graphic materials from existing content
 - Travel bookings

- The use of corporate resources to communicate and schedule meetings/events with Spanish partners as well as start-ups and other colleagues and stakeholders at EU level.
- Supporting the review of project indicators of projects led by partners of the CLC Spain.
- Supporting the reporting of metrics (KPI) related to meetings and events to ensure timely completion of deliverables, accuracy, effectiveness of the work and within budget.
- Planning and execution of follow-up actions for the completion of key requirements.
- Becoming the responsible person of procurement procedures and quality assessment.

This is an exciting time to join the team at EIT Health and the position provides a fantastic opportunity to make a positive and meaningful impact, as we continue to grow the EIT Health network, improve and increase the offered services and enhance our profile within the European healthcare ecosystem.

Essential criteria

- Final-Year Student, Recent Graduated or University Master's Student in Informatics/Telecommunication Engineering, Business Administration or a relevant field, who would like to combine their studies with work.
- Possibility of concluding a training contract with your University; we are searching for a collaboration within a trainee framework.
- Interest in science, technology, innovation and the healthcare sector in Spain and Europe.
- Excellent digital literacy (at least MS Office suite and digital communication tools). Demonstrable hands-on experience on office/IT tools, software and applications (Access or similar) and platforms (SharePoint or similar), at least as an advanced user. Clear understanding of digital security, especially access/permission processes and hierarchies. **Please clearly specify relevant knowledge, skills and experience in your CV and motivation letter.**
- Capacity and willingness to work in an international work environment, with English and Spanish as main languages. Clear, effective written and verbal communication skills. The work will involve remote communication with our colleagues in the CLC, headquarters (HQ) and other EU nodes.
- Client-focused approach. The work will have an iterative format, including directly gathering requirements from and testing with activity leaders and master contacts of EIT Health partners and other stakeholders (e.g. public administration, procurement or consultancy companies...)
- Excellent team-working skills and capacity to work independently, in dynamic and multidisciplinary environments, both face-to-face and remotely. Ability to adapt in a fast-paced constantly changing environment. Self-starter, ability to use initiative, good work ethics with a can-do attitude.
- Demonstrable analytical thinking and problem-solving capacities. Capacity to prioritize and manage a variety of tasks.
- Detail and quality-oriented person.
- Interest in the implementation/use of standards and compliance with regulation.

Desirable criteria

- Knowledge of other European languages, including official languages of the CLC Spain.
- Ability to use meeting scheduling, events management tools and networking software packages.
- Creative skills and experience using design tools to create presentations or graphic materials.
- Knowledge or experience in (self) implementation of time and project management methodologies (e.g. GTD, S3, Agile, Kanban).
- Legal/Financial knowledge, especially of the Horizon 2020/Horizon Europe AMGA Framework.
- Knowledge or experience in implementation of ISO requirements/Quality norms (e.g. ISO 30301:2011, ISO 27001:2013) and regulation (e.g. GDPR, ePrivacy Regulation).
