The primary purpose of this role is to oversee the implementation of new legislation, guidelines, and regulations concerning animal care and welfare, while managing the Animal Experimentation Ethics Committee (AEEC). It includes supervising the Vet Services department, ensuring the health and welfare of animals housed at Ana Path Research S.A.U., and overseeing all environmental controls in the Animal House (AH). Additionally, the role involves responsibility for the experimental surgical procedures, and the development of new techniques.
